Bitches in season will be refunded their entry fee(s) minus a \$5.00 service fee (Veterinarian statement must accompany request)

- Please note jump height on entry form.

- These trials are open to dogs at least six months of age, and registered with the United Kennel Club. Mixed breeds are welcome, but must be UKC registered.

- All dogs must check in a half-hour before their class starts. We are on the same time as Chicago, IL.

- Returned checks do no constitute a valid entry.

- Building is climate controlled.

- Limited crating space. No exercise pens. There will be no bitches in season allowed on premises and there is no space for un-entered dogs.

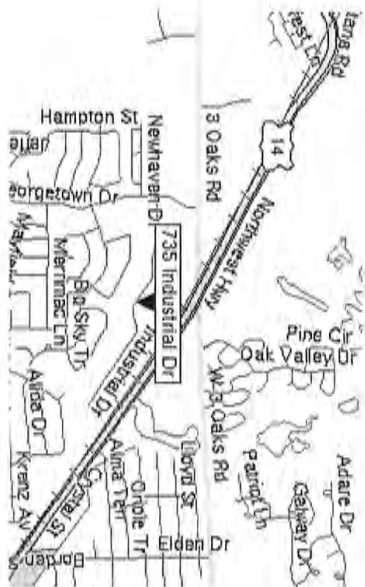
- Safety of dogs is our primary concern.

3. Mail all completed entry forms to the Event Secretary listed under the event, unless otherwise specified. Make checks payable to host club.
4. All UKC Performance events are open to any UKC registered dogs and dogs with a valid Performance Listing/Unlimited Privilege number, with the exception of Lure Coursing and Drag Racing. Please see the rules for each event regarding eligibility.
5. We want you to keep the points earned at UKC Licensed events.
Important things to remember:
• Dog not UKC registered? Apply for a Temporary Listing Number (TL) online at www.ukcdogs.com or call the Dog Events Department at (269) 343-9100. (TL fees are non-refundable, non-transferable and do not apply to the cost of permanent registration.)
• All dogs entering UKC events must be permanently registered, have a valid Temporary Listing Number, or a Performance Listing/Unlimited Privilege number.
• All entry forms must be completed and signed. Incorrect information submitted on the entry form may invalidate your wins.
