GAMES

<u>Eligibility</u> – This trial is open to all dogs measuring 20" or less at the withers and over the age of 12_months, except bitches in season, aggressive dogs or dogs suffering from any deformity, injury or illness which may affect a dog's physical or mental performance.

Your dog must be registered with TDAA to participate in TDAA Trials.

There is a registration form included in this premium, or you can register the first day of the trial. TDAA rules can be obtained online in the form of a PDF file at <u>www.k9tdaa.com</u>

CLASS INFORMATION

Standard Class

Beginner Agility – All dogs shall be eligible for participation in this class. No grandfathering of titles from other organizations is allowed.

Intermediate Agility - Only dogs that have earned the Teacup Beginner Agile Dog (TBAD) shall be eligible for participation in this class.

Superior Agility – Only dogs that have earned the Teacup Intermediate Agile Dog (TIAD) or Teacup Superior Agile Dog (TSAD) shall be eligible for participation in this class.

Games Classes

Games I – All dogs shall be eligible for participation in this class. No grandfathering of titles from other organizations is allowed.

Games II – Only dogs that have earned the Games I (TG1) shall be eligible for participation in this class.

Games III – Only dogs that have earned the Games II (TG2) or Games III (TG3) shall be eligible for participation in this class.

FEO (FOR EXHIBITION ONLY)

FEO– Runs are open to any TDAA-registered dog in any class. FEO dogs will run last in their jump height and may run on lead. FEO teams receive 1.5 times the SCT for their level. FEO runs do not count toward TDAA titles or certificates and no ribbons are awarded.

Twelve-Tone Row

Twelve Tone Row is a dog's-choice game in which exactly 12 obstacles must be performed for points. Each obstacle has a different value; and sometimes a single obstacle has different values depending on the direction taken. The 12th obstacle is required to be an obstacle designated by the judge (usually the weave poles). Twelve-Tone Row is scored Points, Minus Faults, Then Time. ER6.

<u>Boomerang</u>

Boomerang is a game where the dog must perform obstacles to accumulate points. Once the dog goes through the red tunnel if he returns on the same path to the start of that sequence, he will receive a bonus for a successful "Boomerang Throw". Boomerang is scored Points plus Bonus then time ER8.

Scamper

Scamper is a dog's strategic choice game featuring a pipe tunnel surrounded by other obstacles (usually only 5 or 6) only once followed by a central pipe tunnel. Scamper is scored Time, Plus Faults. ER5

JUDGE'S BRIEFING ON DAY OF TRIAL SUPERCEDES ANY PREVIOUS BRIEFINGS.

NOTICE TO EXHIBITORS

- * The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.
- * All dogs must be on leash or crated at all times except when in the ring or when in designated areas (warm-up area). It is expressly understood the exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, **no refund of any fees will be made**.
- * Handlers are not allowed to use whistles or other instruments or devices.
- * Food and toys are allowed in the ring in accordance with TDAA Rules and Regulations.
- * Exhibitors are responsible for being at the ring gate when it is their turn to run.
- * Exhibitors may wear shirts or insignia of their training group if they wish.
- * At the handler's option, the dog may wear a flat (buckle or quick release) collar with or without tags or wear adornments, clothing, ties or other attachments. Choke collars, pinch collars, electric and dummy electric collars are prohibited.
- * Unsportsmanlike conduct, including rough handling or misconduct of any kind, will result in an excusal from the ring.
- * Entries will not be accepted without fees. No entries will be accepted which require a signature for delivery. All entries must be submitted on official TDAA Agility Entry Forms, one dog per entry form.
- * Photocopied entries without the TDAA agreement on the back are NOT acceptable. Unsigned, incomplete or illegible entries are NOT acceptable and cannot be entered in the trial. Faxed entries and/or credit cards cannot be accepted. Returned checks do not constitute a valid entry fee.
- * The Trial Secretary will add a \$30.00 service charge for any returned checks. Subsequent returned checks from the same exhibitor may result in their being put on a CASH ONLY basis.
- * Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Trial Committee.
- * No entry fee will be refunded if the trial cannot be opened or completed by reason of riots, civil disturbance, fire, an act of God, public emergency, an act of public enemy, or any other cause beyond the control of the organizing committee.
- ^b Bitches in season are not permitted at the trial. <u>The club will refund all but \$6.00</u> of the entry fee for bitches unable to compete for that reason. The Trial Secretary must receive written notification from a veterinarian of such claim for refund to the Trial Secretary by 8:00 a.m. day of the trial.

Height Divisions

Owners are responsible for entering the proper height division. Judges reserve the right to measure dogs entered in any trial. Judge will be available to measure dogs who have not been measured. At the handler's option, dogs may be entered in any jump height desired; however, the scoring height continues to be the dog's measured jump height. Dogs jumping at a height other than their measured height will earn qualifying legs and all TDAA titles. TDAA height divisions are as follows:

ALL DOGS WITHOUT A PERMANENT HEIGHT CARD must be measured prior to the first day of competing at this trial. Arrive early enough to

accommodate measuring.

2" jump height - For dogs with a jump height exemption measuring 8" or less

4" jump height – For dogs measuring 8" or less at the withers; or dogs with a jump height exemption measuring 12" or less

8" jump height - For dogs measuring 12" or less at the withers; or dogs with a jump height exemption measuring 16" or less.

12" jump height – For dogs measuring 16" or less at the withers; or dogs with a jump height exemption measuring 20" or less.

16" jump height – For dogs measuring 20" or less at the withers.

Jump Height Exemptions

Special provisions are made for dogs that are long-backed, have a weight-toheight exemption, or who have dwarfish legs (see www.k9tdaa.com, Rules, Sec. 3.5.5 for description of height exemptions). A jump height exemption (next lower height) will also be granted to veteran dogs (dogs of at least 7 years of age). You may subtract one height for Veteran status and one for Body Exemption from Measured Jump Height. Some handlers prefer to jump at other heights, as allowed under the TDAA Rules and Regulations.

<u>Handicapped Handlers</u>: Disabled handlers will be allowed an additional 4 seconds in Standard and Games classes using numbered courses. A copy of a disabled parking permit must be sent with the entry.

Lunch will be provided. If you would like to bring something to share, please contact the trial secretary.

Show Site:

This trial will be held indoors on $\frac{3}{4}$ " matting. Please bring mats for under crates.

Exhibitors are responsible for providing a mat to put under crates and chairs to protect our surface.

PLEASE PICK UP AFTER YOUR DOG AT THE SHOW SITE AND HOTELS

All dogs must be kept on leash except in designated areas.
