Make checks payable to NOCI. Send completed form and fees to Trial Secretary. All entries must be submitted on official UKC entry form. Entries will not be accepted without signature, fees and correctly filled out entry form. Entry fees will not be refunded in the event a dog is absent, disqualified, excused by judge or veterinarian, or barred from competition by action of the show committee or UKC. No refunds after limit is reached except for bitches that come in season after the closing date of the trial minus a \$5.00 handling fee with a veterinarian's certificate prior to the start of the trial.

These trials are open to dogs at least six months of age, and registered with the United Kennel Club. Mixed breeds are welcome, but must be UKC registered.

All dogs must be checked in a half-hour before their class starts. We are on the same time zone as Chicago.

Returned checks do not constitute a valid entry.

Safety of dogs is our primary concern.


